RESOLUTON AUTHORIZING THE TOWN SUPERVISOR TO SIGN A TWO-YEAR CONTRACT FOR SNOW AND ICE CONTROL ON COUNTY ROADS FOR THE PERIOD OF JANUARY 1, 2025 TO DECEMBER 31, 2026

WHEREAS the Montgomery County Commissioner of Public Works is seeking a contract to enter in with the towns for snow and ice control on County roads within the Town of Minden under Section 135A of the Highway Law, and

WHEREAS the county has agreed upon the amount for the 2025 year \$6,545.65 per mile and for the 2026 year \$6,774.75 per mile, and whereby such contract filed in the town clerk's office shall be abided by both parties; and

BE IT RESOLVED, that pursuant to Section 135A of the Highway Law, this Board authorizes and directs the supervisor to sign the county contract for snow removal and ice control for the sum of \$6,545.65 per mile for the year of 2025 and \$6,774.75 per mile for the year of 2026.

FURTHER RESOLVED, the Town Supervisor is authorized to sign a (2) two-year contract for snow and ice control on county roads for the period of January 1, 2025 - December 31, 2026.
